WHAT IS AN OUTSOURCED LEGAL DEPARTMENT?

Not all companies have the resources or the scale required to establish an in-house legal department and bear the associated costs. Yet these companies need advice on their relationships with third parties — suppliers, clients, partners and subcontractors — to manage the risks inherent in their activities and to integrate the legal dimension into their strategy.

For this reason, our firm offers SMEs, mid-sized companies (ETI) and start-ups access to an experienced attorney, acting as an outsourced Legal Department and, if you wish, working directly from your premises.

WHAT ARE THE BENEFITS OF AN OUTSOURCED LEGAL DEPARTMENT ?

The attorney made available to you has an in-depth knowledge of the issues encountered by businesses, having practised both in a law firm and as a seconded lawyer within start-ups and mid-sized companies, in direct contact with operational teams. They bring a diverse skill set and act pragmatically to provide secure, operational solutions to the challenges you face.

Their "business-oriented" approach and knowledge of contractual practices across the various sectors in which their clients operate allow for a high degree of responsiveness in delivering services. Finally, the establishment of an outsourced Legal Department allows companies to retain great flexibility, adapted to their growth, economic circumstances and concrete needs.

WHAT NEEDS CAN WE COVER ?

Our services cover the following needs:

- Corporate secretarial work and maintenance of corporate registers;
- Drafting and negotiating commercial contracts (supply, distribution, subcontracting, general terms and conditions, etc.), service agreements, IT contracts and intellectual property rights exploitation agreements (partnership, consortium, assignment, licence, etc.);
- Advisory services in commercial law, distribution law and competition law;
- Advisory services in intellectual property law and new technologies (internet law);

- Implementation of internal policies (compliance policies, employee invention remuneration policies, etc.);

WHAT ARE THE COSTS OF ESTABLISHING AN OUTSOURCED LEGAL DEPARTMENT?

In practice, this involves setting up a monthly subscription, with the volume of intervention days to be determined according to the company's needs. It may range from one (1) to eight (8) days per month, over a period of two, three, six, nine or twelve months.

The applicable daily rate will naturally be on a sliding scale depending on the volume and frequency selected.

As an alternative we also propose a retainer model : a fixed annual fee is due to cover a determined number of works (number of contracts reviews, maintenance of terms and conditions up-to-date, management of GDPR and AI Act compliance, management of other compliance obligations, training for business department on how to use the contractual package we set up for you, set up of a contract management tool to follow-up your signed contracts, ...

The firm's standard hourly rates do not apply within the framework of these subscriptions.

The establishment of an outsourced Legal Department may include a hotline.

The volume and pricing of the subscription will be proposed following a rapid audit of your specific needs and based on the risks the company wishes to mitigate.

This subscription may also include the attorney's participation in the strategic committee or any similar committee within the company, so that legal considerations are integrated into the company's economic and strategic thinking.
